Na feidhmeanna a bhaineann leis an leathanach facebook scoile ná chun:

- Cumarsáid a dhéanamh le tuismitheoirí maidir le gníomhachtaí scoile.
- Cumarsáid a dhéanamh le tuismitheoirí nua
- Cumarsáid go poiblí a dhéanamh maidir le fograíocht na scoile agus dátaí clarúcháin
- Cumarsáid go poiblí a dhéanamh faoin ár saol scoile - turasanna scoile, tionscadail, fógraí srl.
- Cumarsáid idir tuismitheoirí, ach go háirithe tuismitheoirí nua.
- Ár gcóras cumarsáide scoile a chur chun cinn tré eolas a roinnt lena chéile - ríomhphost, nótaí scoile, nuachtlitreacha, suíomh idirlíona agus anois facebook.

Caithfidh daoine a úsáideann ár leathanach na rialacha seo a leanúint:

- Ní féidir l'úsáideoirí aon táirigí nó séirbhís a fhógairt ar an leathanach
- Ní féidir l'úsáideoirí aon rud ionsaitheach a chur ar an leathanach. Bainfear aon nótaí tráchta míchuí nó dochrach láthaireach.
- Níor chóir do úsáideoirí nótaí tráchta diúltach a scríobh ar an leathanach. Tá sé níos oiriúnach deileáil leis an scoil go díreach agus an polasaí "gearáin tuistí" a leanúint.
- Níor chóir d'aon úsáideoir tagairt diúltach a dhéanamh faoi éinne ar fhoireann na scoile
- Níor chóir do úsáideoirí iarraidh ar fhoireann na scoile a bheith "cairdiúl" leo.
- Ní féidir l'úsáideoirí griangraif do pháistí a chur ar an leathanach nó "tag" a chur ar aon ghriangraf do pháiste.
- Níl cead ag aon úsáideoir aon nótaí tráchta a chur ar an leathanach inar féidir páistí a aithint.
- Chun facebook a úsáid caithfidh duine a bheith 13 nó níos sine. Mar sin ní cheadaítear le páistí na scoile mar úsáideoirí.
- Users will not mention individual staff members in a negative light on the school facebook page.

The purpose having of a school Facebook page is to provide;

- Communication with parents regarding specific events & activities
- Communication with new or prospective parents
- Communication with wider audience regarding positive advertisement of school & enrolment dates
- Communication with wider audience of school life via possible communication tours - photos of pupil's projects, notice boards, etc.
- Communication between parents especially new parents
- Continued advancement of our school communication system with information shared via paper notes, email, website & now Facebook

Those using our social networking site must abide by the following;

- Users cannot advertise products or services on our school Facebook page
- Users should not post anything on the page that could be deemed as offensive - inappropriate or harmful comments/content will be removed immediately
- Users should not post negative comments or give negative feedback on facebook. It is more appropriate to deal with the school directly on such matters, and follow the schools complaints procedure.
- Users will not mention individual staff members in a negative light on the school facebook page.
- Users should not ask to become "friends" with staff as failure to respond may cause offence
- Users cannot tag or post photographs of children on the page
- Users should not add comments that can identify children
- To use Facebook, one must be 13 years of age or older. Therefore current pupils cannot be accepted as users.

The sanction for breaking these rules is automatic removal from our facebook page.

Our school facebook page will be live, on a trial basis until February 18th 2014.

No pictures/tags of any child will be posted by the school. Our intended purpose of the facebook page is communication and to share information.
